Absences / Questions

The clerkship office must be notified of all absences. If you know in advance that you have an appointment or school meeting, let the clerkship office know as soon as possible. What to do for an exposure to blood/body fluids . . .

An exposure is a needlestick, cut, puncture wound, mucous membrane splash or a cutaneous exposure (especially if the skin is broken).

1. Wash exposed site immediately.

For needlestick, cut, puncture wound or cutaneous exposure, wash with soap and water.

For mucous membrane splash (eyes, nose, mouth), flush with water only for fifteen minutes.

2. **IMMEDIATELY** Contact SIU Infection Control by phone (217/545-8970).

If exposure occurs after 4:30 p.m., or on a weekend or holiday, contact the SIU Infectious Disease physician on call (217/545-5880); contact the Infection Control (IC) Nurse the next working day.

If exposure occurs at a satellite or preceptor site, follow the site's procedures for exposure; contact the IC Nurse as soon as possible.

3. Complete a Report of Exposure form. (Obtain from Infection Control Nurse.)

Describe incident in detail, including route of exposure, description of the student’s duties as they relate to the exposure, and type of device used during exposure.

Include information about the source patient, if known (name, medical record number, date of birth, and physician name).

Undergarments	<ul style="list-style-type: none"> • Required, discreet 	<ul style="list-style-type: none"> • Bright and/or noticeable colors, patterns or lines
Accessories	<ul style="list-style-type: none"> • Conservative jewelry with moderation 	<ul style="list-style-type: none"> • Visible body piercings other than conservative earrings in the ear • No jewelry (except a watch) can be worn in the OR
Labcoats	<ul style="list-style-type: none"> • Protective garment • May be worn over surgical scrubs or business attire 	<ul style="list-style-type: none"> • Dirty, torn, or wrinkled
Grooming	<ul style="list-style-type: none"> • Clean and neat • Hair neatly cut and styled • Conservative use of cosmetics, nail polish, colognes and perfumes • Long hair must be pulled back away from the face 	<ul style="list-style-type: none"> • Long nails that could cause discomfort for patients • No artificial nails or nail polish can be worn in OR
Name Tags	<ul style="list-style-type: none"> • Worn at all times • Worn on upper torso 	<ul style="list-style-type: none"> • Damaged or peeling • Multiple decorative stickers
