
National Library Week Events

CAVE: Video Editing Workstation

Visit the Library's new high-end video editing workstation housed in the CAVE (Create Audio and Video for Education) in room 4125.

The CAVE provides faculty, students, and staff with access to specialized equipment and software for the development of audio and video material for teaching and learning.

The CAVE workstation runs Windows 7 x64, and has 16GB of memory, a 1.8TB data drive, dual flat panel displays, and an analog to digital video converter.

Software includes Adobe Creative Suite CS6 (including Adobe Premiere Pro), Adobe Captivate, Camtasia, Audacity, and additional video and audio conversion programs (see our Guide http://libguides.siumed.edu/cave for a complete listing).

The American Grants & Loans Database

Access to the American Grants & Loans Database or Grantsinfo.us for 2013 is now available. Updated daily, access is provided to more than 2800 financial programs, subsidies, scholarships, grants and loans offered by the US federal government. Information on over 2400 programs funded by private corporations and foundations is also included.

These resources are compiled by experts to provide the best data accuracy. It is both keyword and agency searchable enabling access to program information by specific fields of interests. Each entry provides detailed contact information as well as the following data:

- Web link to program announcement page
- Web link to Federal agency or foundation administering the program
- Authorization upon which a program is based
- Objectives and goals of the program
- Types of financial assistance offered under a program
- Uses and restrictions placed upon a program

- Eligibility requirements
- Application and award process

The American Grants & Loans Catalog is also available on CD for use in the Library . A link to the online database can be found on the Library's E-Resources page (http://www.siumed.edu/lib/eresources.html).

A subject guide has been developed on grants and funding sources.


The guide is divided into federal, state, private and association funding sources. Also included are lists of current books availa-

Good Reads

Askin, Elisabeth and Moore, Nathan. The Health Care Handbook: A clear and concise guide to the United States health care system. St. Louis: Washington University, 2012. [W 84AA1 A835h 2012]

When two Wash U medical students tried to find a short, clear guide to the U.S. health system and failed, they decided to write their own! When they started, the Affordable Care Act had just passed, and it had just been upheld by the Supreme Court as they went to press.

The major chapters are Health

Care Systems and Delivery; Health Care Providers; Insurance and Economics; Research, Pharmaceuticals, and Medical Devices; and Policy and Reform, including an Affordable Care Act FAQ.

This attractive book is full of illustrations and charts. One section details 32 health care provider categories, including for each type: education, licensing, job description, average salary, and work location. Trying to understand the insurance world? There's a section that explains information asymmetry,

moral hazard, adverse selection, supply-induced demand, and behavioral economics concepts, including anchoring fallacy, cognitive framing, and time inconsistency (all this in five brief pages!).

This book is chock-full of information and fun to read. And all the more impressive because it was written by medical students (we are assured in the introduction that they stayed in good standing during its writing, which took only four months for the first draft and production in less than a year)!

Highlighted Resource: Cases Database



BioMed Central recently launched Cases Database (http://

www.casesdatabase.com/), an open access case report database.

Case reports included in Cases Database come from all of Bio-Med Central and cover all topics in medicine.

Cases Database is continuously updated and allows users to interactively explore data from thousands of peer-reviewed medical case reports.

The main features of the Cases Database include:

- ◆ Structured search and filtering by condition, symptom, intervention, pathogen, patient demographic and many other data.
- 'My Cases Database' in which registered users can save searches and favorite

- Email alerting to new cases matching your interests.
- Download and export of search results.
- Links to full text of case reports in peer-reviewed journals.
- ♦ Social media integration

Free registration is required to access all the features including 'My Cases Database.'

CARLI PDA Project

Some of you may remember when PDA stood for "personal digital assistant". Now, in the library field, it stands for "patron driven acquisitions".

Borrowing from the just-in-time practices of other industries, some libraries are providing records for materials they do not yet own and buying them upon request. The Consortium of Academic and Research Libraries in Illinois (CARLI) has spon-

sored a PDA program since 2012. In January, the program was expanded to include medical and science books.

These "not-yet-owned" books are represented in the I-Share catalog with a note in the location field that the item will be purchased upon request. Borrowers can request the item just like any other title, and it will receive expedited ordering and cataloging via the University of

Illinois. The book will then be delivered through the regular delivery system.

To see a relevant record, search for "The Chief Concern of Medicine" in the I-Share catalog. This is a title that was available through the PDA project and has been requested, cataloged, and made available for loan.

Exhibit honoring Dean Richard H. Moy, M.D.



Our founding Dean, Dr. Richard Moy passed away Friday, February 15, 2013. Dr. Moy served as Dean, Provost, and Professor of Southern Illinois University School of Medicine 1970-1993.

When he retired in 1993, Dr. Howard Barrows honored his achievements by sketching four caricatures of Dean Moy.

Photographs, achievement awards, and memorabilia from his life are on display from the SIU School of Medicine archives.

Library Q and A
