Individual programs are accountable to GMEC to ensure that learner handoffs are effective. In addition, the SIU GME Quality Improvement Coordinator periodically audits program handoffs. Traditionally, the feedback from these observations were provided just to the program director. In Fall 2016, the decision was made to add an item on consistency of handoff scheduling to the audit rubric and report findings to GMEC.



IMPROVE REPORTING OF ERRORS/NEAR MISSES (carried over from 2014 - 2015)

Residents have two opportunities each year to evaluate various aspects of their training directly to SIU and the ACGME. The ACGME conducts an annual resident survey. The GMEC conducts an annual end of year evaluation for all residents. For 2015-2016, 226 evaluation responses were received from Carbondale, Decatur, Quincy, and Springfield programs for a 67% response rate. Resident input from the SIU end of year evaluations and ACGME resident survey on a variety of training parameters are listed in tables on the following pages.

GMEC set a goal to have 50% of residents report at least one error in any given year. Although we are not yet at that goal, slow progress continues. Our current focus toward this goal is outreach and reinforcement to program directors and faculty about the importance of encouraging and role modeling reporting behavior and to hospital quality personnel about the importance of feedback on reported errors.

PROMOTE AN OUTSTANDING LEARNING AND WORK CLIMATE (carried over from 2014—2015)

We have focused a great deal of energy on improving our learning and work climate for the past two years. Behavioral standards have been delineated and disseminated via multiple routes. The instrument used for residents to evaluate their individual faculty was revised to include specific behaviors associated with a positive learning climate. Multiple programs are now having this evaluation administered via the Office of Residency Affairs, to increase resident confidence regarding confidentiality.

The benchmark of a healthy learning or work climate is an atmosphere where individuals feel safe and comfortable expressing opinions or raising concerns. We have opted to track this item as one outcome measure for our efforts. As you can see from Figure 5 on the following page, we still have considerable work to do. Although much of the learning climate rests on individual learner-supervisor interactions, we believe that our efforts are being impacted by factors external to GME (faculty workload, massive changes in the structure and organization of some of our major services and sequela of the Illinois budget crisis). Our work continues.

CONTINUED EFFORTS REGARDING OVERSIGHT OF SUPERVISION (carried over from 2014–2015)

Residents are surveyed regularly about their supervision experiences. In response to the question "in the past year have you been placed in a situation or witnessed one of your peers placed in a situation where you believe there was inadequate supervision?", resident responses have ranged from 13% (2015) to 20% (2014 and 2016). For 2016, we believe that a large number of the responses related to ICU settings. Starting in July 2016, we have drastically reduced the number of PGY1 learners in ICUs and increased the level of supervision for those that remain.

Audits are conducted by the SIU SOM Office of Compliance and Ethics for compliance with supervision standards. To date, five surgical programs have been reviewed with feedback and training provided for the faculty, and an additional two are underway. In addition, we are always looking at ways to improve communication between the chief medical officers (CMOs), SIU HealthCare and our Springfield hospitals to ensure that the appropriate individuals receive timely feedback should supervision issues be identified.

IMPROVE FACULTY SKILLS AND KNOWLEDGE IN PATIENT SAFETY AND HEALTH CARE QUALITY (new goal)

Plans are underway to develop and adopt a common set of patient safety and quality learning objectives for all SIU SOM faculty and learners.

2016 Outstanding Coordinator Award



Tina Hartwig, Program Coordinator at Decatur Family & Community Medicine, was nominated for and awarded the 2016 Outstanding Coordinator Award. Ms. Hartwig has been in this role for over eight years.

This will be an annual award sponsored by the Office of Residency Affairs and given to a GME program coordinator. The coordinator must be in this role for a minimum of one year, and must demonstrate a commitment to the mission and behavioral standards of SIU School of Medicine. A committee meets to review the nominations and select an award winner.

The award winner consistently demonstrates the following behaviors:

- provides excellent service to internal and external contacts;
- displays compassion, respect, integrity, and accountability in their work;
- promotes diversity and inclusion;
- seeks continuous learning and improvement opportunities; and
- consistently meets deadlines.



Duty Hours

Oversight of duty hour compliance is a core GMEC responsibility. Duty hour violations per program are reviewed quarterly by GMEC. Additional compliance data is gathered from the ACGME Resident Survey and the SIU End of Year Evaluation. Data collected during the last two academic years regarding duty hour rule compliance is displayed in Figure 16 for Springfield residents. Each violation represents one instance out of all hours worked by all residents for the year.

Quality & Patient Safety

The ACGME Clinical Learning Environment Review (CLER) program was developed to promote and improve how clinical teaching sites engage resident and fellow physicians in learning to provide safe, high quality patient care by providing feedback in 6 focus areas:



SIU had its second CLER visit in August 2016. The report from the ACGME is not available at the time of this writing.

In 2015-2016, the requirement that all residents must participate in a RCA (Mock or real) and must provide documentation that they have reported a patient safety event was established. Information on how the residents could provide documentation for the near miss/adverse event was provided to all programs. A universal tool was developed for residents to evaluate their faculty supervisors on the effectiveness of their clinical teaching skills. The tool was made available to all programs to use with the option of having the GME office administer the evaluations at a program level. A resident quality improvement poster competition and symposium was approved to be held in the fall of 2016.
